I. Situation Overview

On 13 March 2022 at around 4:42 AM, a fire incident transpired in Sagip Street, Barangay Arkong Bato, Valenzuela City.

A total of **329 families** or **1,318 persons** sought temporary shelter in the **Arkong Bato Elementary School** and **R. San Diego Elementary School** (see Table 2).
