

DSWD DROMIC Report #1 on the Fire Incident in Brgy. San Nicolas Baao, Camarines Sur as of 16 July 2022, 6PM

I. Situation Overview

On 15 July 2022 at around 4PM, a fire incident occurred in Brgy. San Nicolas, Baao, Camarines Sur. The Bureau of Fire Protection (BFP) - Baao declared the fire out at 6:00 PM of the same day.
