

DSWD DROMIC Report #1 on the Fire Incident in Brgy. 76-A, Bucana, Davao City as of 25 August 2022, 6PM

I. Situation Overview

On 22 August 2022 at around 3:30 PM, a fire incident occurred in Brgy. 76-A, Bucana, Davao City. The cause of the fire is still being investigated.

A total of **210 families** or **690 persons** are affected in **Brgy. 76-A, Bucana, Davao City** (see Table 1).

a. Inside Evacuation Center

There are **210 families** or **690 persons** currently taking temporary shelter in **two (2) evacuation centers** in **Davao City** (see Table 2).
