I. Situation Overview

On 04 August 2022, a fire incident occurred in DOTC Compound, Purok 1, Cabasaan Street, Brgy. New Lower Bicutan, Taguig City. The fire was declared under control at 2:49 PM. The cause of fire is still under investigation.

1. Standby Funds

- ₱124.38 million Quick Response Fund (QRF) at the DSWD Central Office.
- ₱5 million available at DSWD FO NCR.

2. Prepositioned FFPs and Other Relief Items

- 97,778 FFPs available in Disaster Response Centers; of which, 46,049 FFPs are at the National Resource Operations Center (NROC), Pasay City and 51,729 FFPs are at the Visayas Disaster Resource Center (VDRC), Mandaue City.
- 2,019 FFPs available at DSWD FO NCR.
- ₱151.51 million worth of other FNIs at NROC, VDRC and DSWD FO NCR warehouses.

b. Camp Coordination and Camp Management (CCCM)

The LGU of Taguig City through its CSWDO is continuously coordinating with concerned agencies and conducting assessment and validation of the affected families using the Disaster Assistance Family Access Card (DAFAC) / White Card for the affected families.
