

**DSWD DROMIC Terminal Report on the Fire Incident in
Brgy. Sooc, Arevalo, Iloilo City**
04 October 2022, 6PM

I. Situation Overview

On 08 August 2022 at around 11:30 PM, a fire incident occurred in Brgy. Sooc, Arevalo, Iloilo City. Based on the investigation conducted by the Bureau of Fire Protection (BFP), the fire ignited from a faulty electrical wiring. The fire was declared out at 12 PM.
