

DSWD DROMIC Preparedness for Response Report #2 on the Low Pressure Area (LPA)

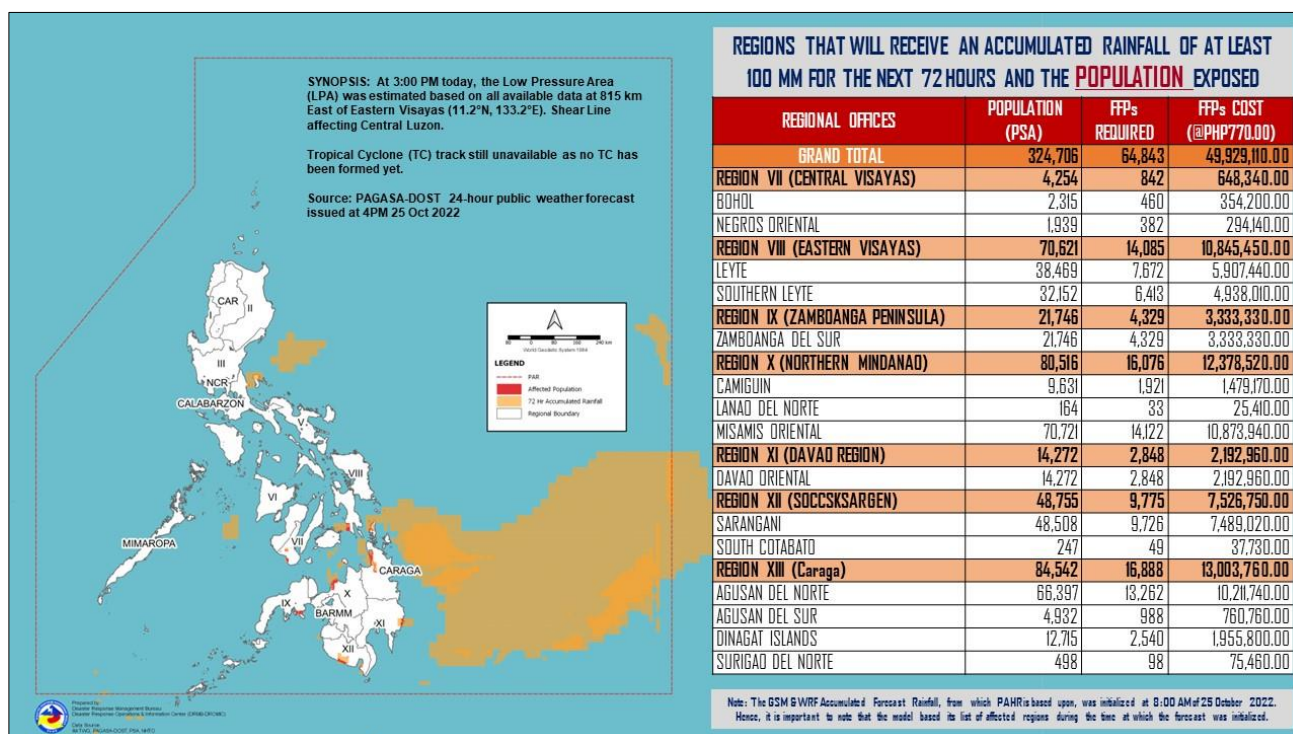

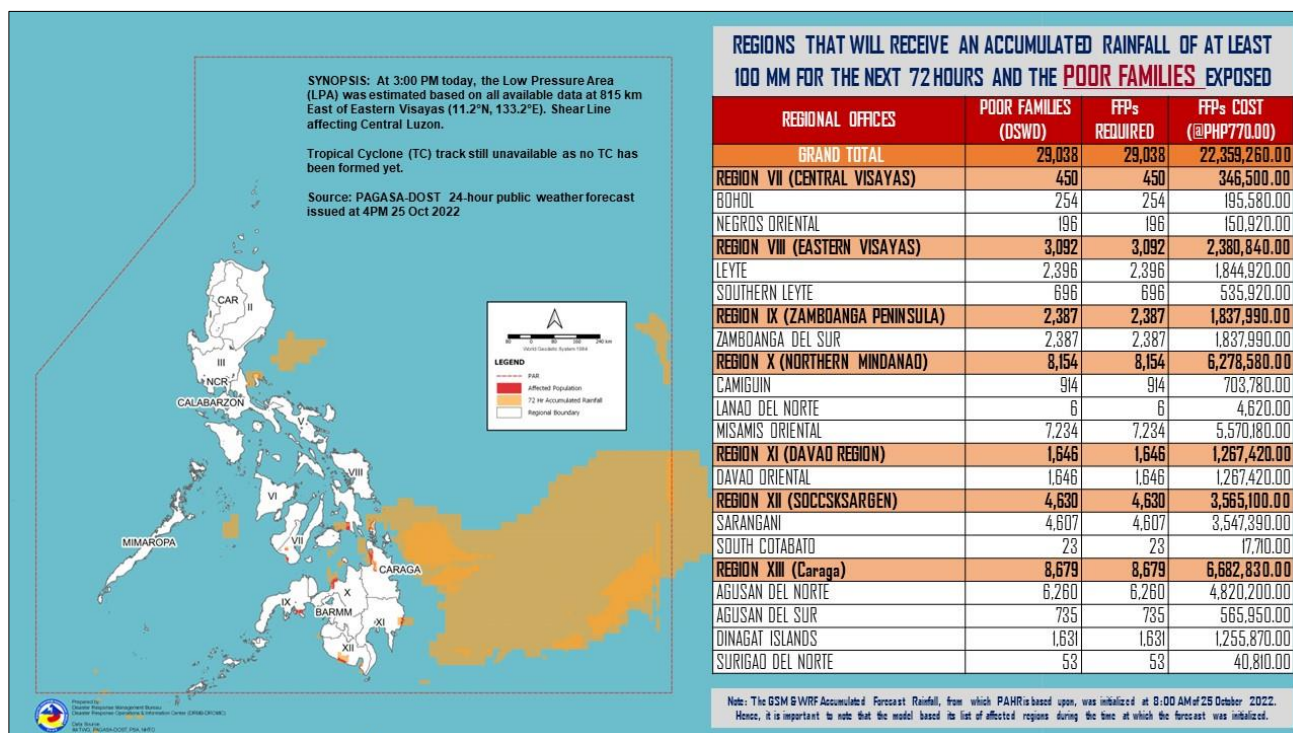
Situation Overview

Issued on 25 October 2022 at 10 AM, the Low-Pressure Area (LPA) was estimated based on all available data at 820 KM east of Eastern Visayas (10.3°N, 133.7°E). This weather disturbance may develop into a Tropical Depression within 72 hours. Hazards affecting land areas in the next 24 hours, the effect of shearline and Intertropical Convergence Zone (ITCZ) will bring moderate to heavy with at times intense rains over Aurora, Quezon, and Eastern Visayas. Meanwhile, light to moderate with at times heavy rains will prevail over Cagayan, Isabela, Apayao, the rest of Central Luzon, Metro Manila, Rizal, Laguna, Central Visayas, Caraga, and Northern Mindanao. Under these conditions, flooding and rain-induced landslides are likely, especially in areas that are highly or very highly susceptible to these hazards as identified in hazard maps and in areas with significant antecedent rainfall. The public and Disaster Risk Reduction and Management Offices concerned are advised to take all necessary measures to protect life and property.

Status of Prepositioned Resources: Stockpile and Standby Funds

The DSWD Central Office (CO), Field Offices (FOs), and National Resource Operations Center (NROC) have stockpiles and standby funds amounting to **₱1,883,831,016.81** with breakdown as follows (see Table 1):

a. Standby Funds

A total of **₱835,446,390.05 standby funds** in the CO and FOs. Of the said amount, **₱762,726,429.48** is the available **Quick Response Fund (QRF)** in the CO.

b. Stockpiles

A total of **555,695 family food packs (FFPs)** amounting to **₱348,267,548.36**, **other food items** amounting to **₱188,112,285.05**, and **non-food items (NFIs)** amounting to **₱512,004,793.35** are available.

24 October 2022	<ul style="list-style-type: none"> DSWD FO CAR monitored weather updates and other related information within the area of responsibility (AOR). The Disaster Response Management Division (DRMD) Quick Response Team (QRT) was on standby at the DRMD Operations Center for the monitoring of AOR. DSWD FO CAR strategically prepositioned relief goods to disaster-prone areas in the Region. DSWD FO CAR ensured availability of FNIs at the DSWD FO CAR Regional and Satellite warehouses. The DRMD Disaster Response focal persons in provinces were actively monitoring their respective AORs for any untoward incident. DSWD FO CAR ensured the availability of transportation and communication services ready for deployment in any case needed. DSWD FO CAR continuously facilitated Relief Prepositioning Agreement (RPA) with LGUs based on guidelines.

DSWD FO V continuously conducted prepositioning of goods to satellite and/or LGU warehouses.

DSWD FO III continuously conducts stockpiling and prepositioning of welfare good at the provincial satellite warehouses. DSWD FO III facilitated the signing of Memorandum of Agreement (MOA) with the Local Water Districts in Central Luzon for the provision of potable drinking water during disaster response operations.

DSWD FO Caraga alerted the Social Welfare and Development (SWAD) Team Leaders in the respective Provincial SWAD Offices to monitor their AORs and provide updates and submit reports with regard to the effect of the LPA. DSWD FO Caraga constantly coordinates with the Local Social Welfare and Development Offices (LSWDOs) to get updates on the situation in their respective localities in relation to the experienced heavy rains due to the effects of the LPA. DSWD FO Caraga QRTs are on standby for possible deployment.

The Disaster Response Operations Monitoring and Information Center (DROMIC) of the DSWD-DRMB is closely monitoring the effects of "LPA" and is closely coordinating with the concerned DSWD Field Offices for any significant updates.
