## V. Cost of Humanitarian Assistance Provided

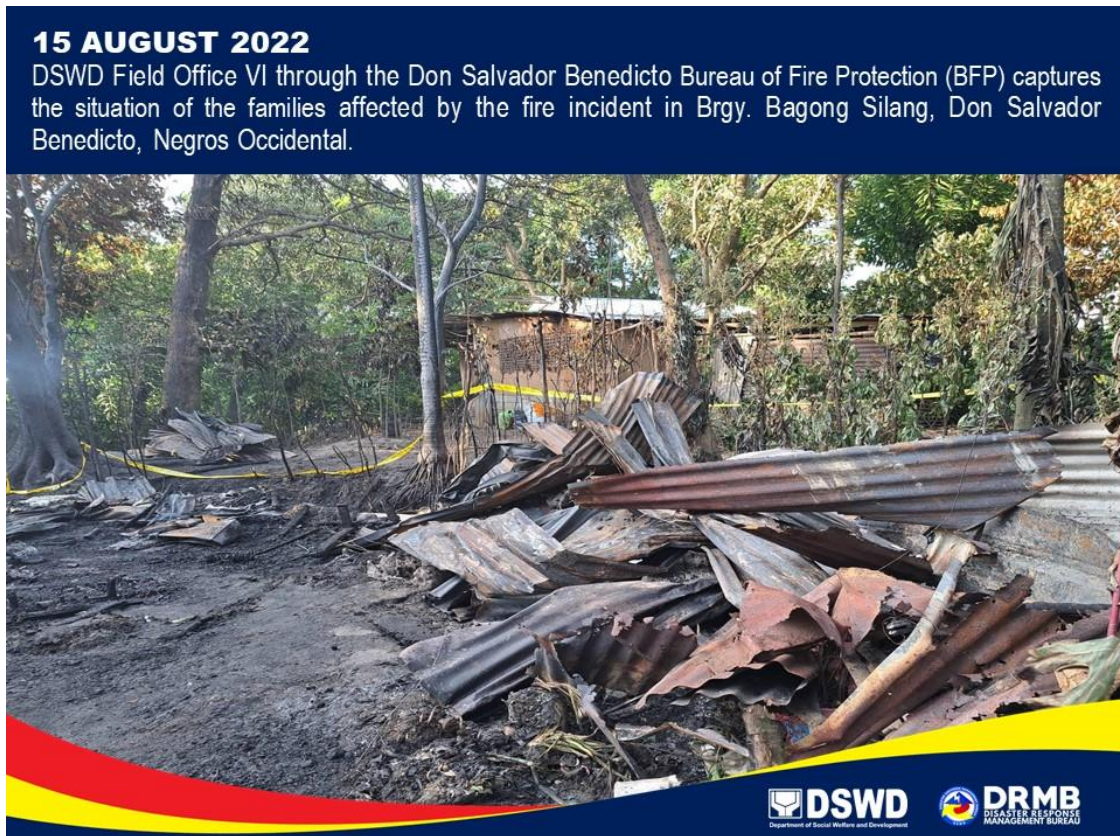
