

DSWD DROMIC Report #4 on Tropical Storm Rosal

as of 12 December 2022, 6PM

I. Situation Overview

Issued on 12 December 2022 at 5PM, "ROSAL" slightly weakens as it continues to move away from the country.

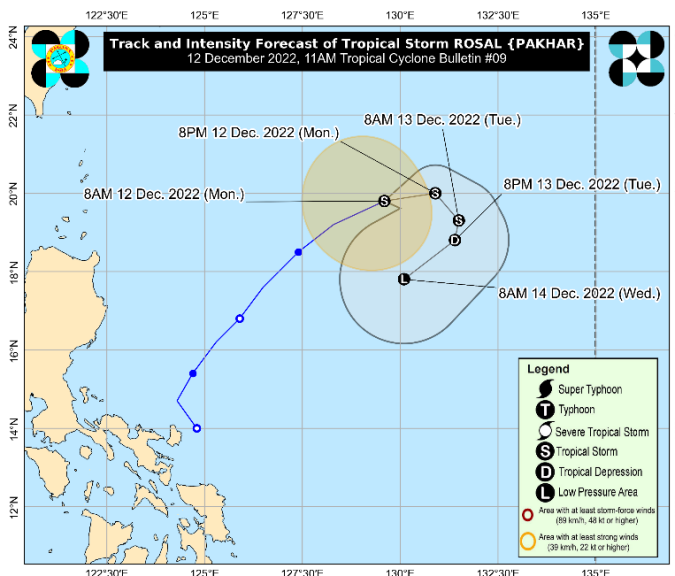
Hazards affecting Land Areas

Heavy Rainfall:

- ROSAL is less likely to directly bring heavy rains (which may trigger flooding or rain-induced landslides) in the country throughout the forecast period.

Severe Winds:

- In the next 24 hours, the surge of the Northeast Monsoon partly enhanced by this tropical storm may bring occasional gusts reaching gale-force over Batanes and strong breeze to near-gale strength over Babuyan Islands, and the coastal and upland areas of Ilocos Norte, northern and eastern Cagayan, and eastern Isabela.



Hazards affecting Coastal Waters

- Under the influence of the surge of the Northeast Monsoon partly enhanced by ROSAL, a marine gale warning is in effect over the seaboard of Northern Luzon. For more information, refer to Gale Warning #27 issued on 12 December 2022 at 5PM.
- In the next 24 hours, the combined effects of the surge of the Northeast Monsoon and the tropical cyclone may also bring moderate to rough seas over the seaboard of Central Luzon (1.5 to 3.5 m) and the eastern seaboard of Southern Luzon and Visayas (1.2 to 3.0 m). These conditions may be risky for those using small seacrafts. Mariners are advised to take precautionary measures when venturing out to sea and, if possible, avoid navigating in these conditions.

Track and Intensity Outlook

- Tropical Storm (TS) ROSAL is forecast to move generally eastward in the next 12 hours before turning southeastward to southward for the remainder of the forecast period. Due to unfavorable environment conditions associated with the surge of the Northeast Monsoon, ROSAL is forecast to rapidly weaken and may become a remnant low tomorrow late evening or on Wednesday early morning before dissipating shortly thereafter.

The center of TS ROSAL was estimated based on all available data at 880 km East of Extreme Northern Luzon (20.0°N, 130.4°E) moving East Northeastward at 15 km/h with a maximum sustained winds of 75 km/h near the center and gustiness of up to 90 km/h.

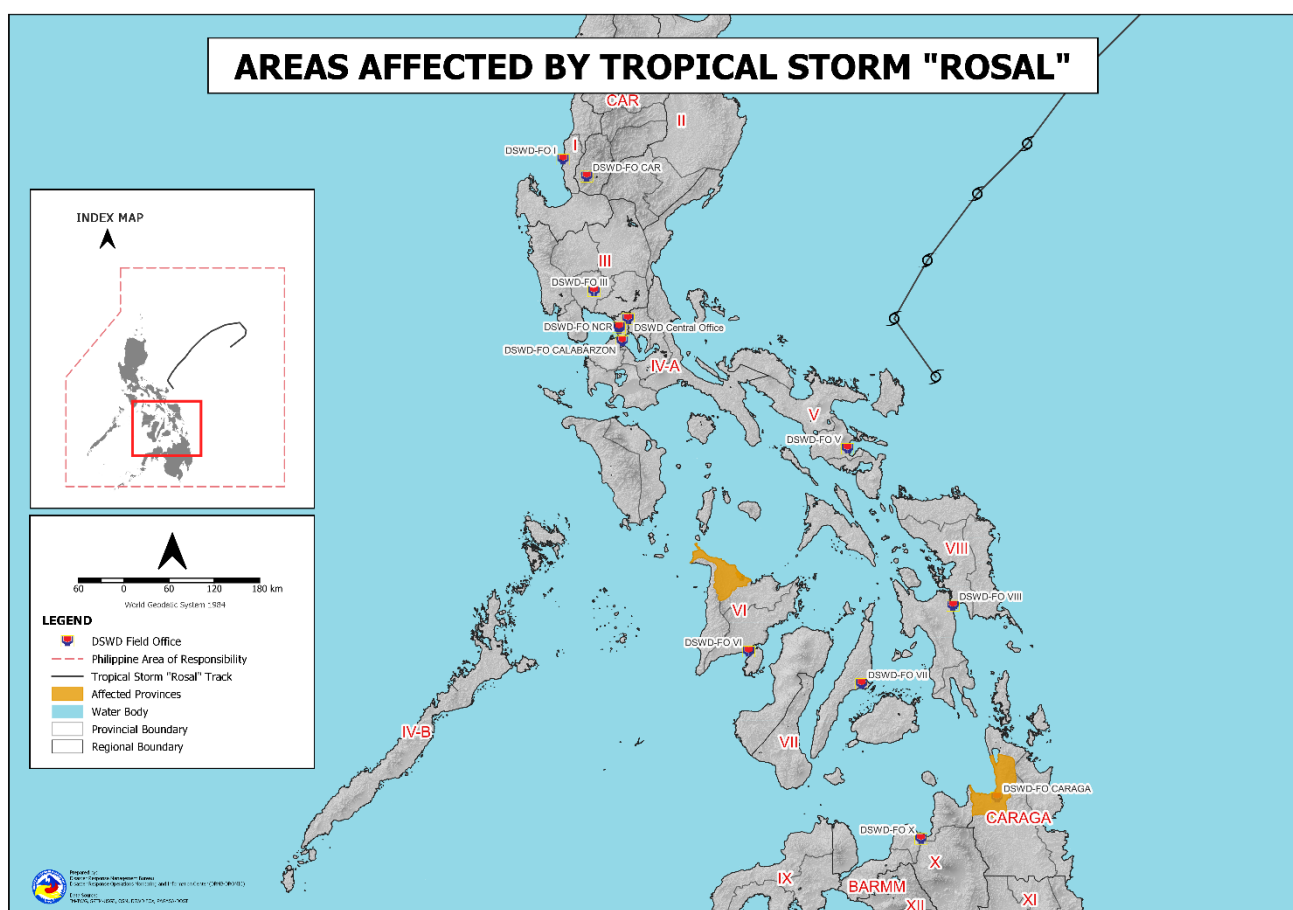
