I. Situation Overview


Issued on 13 December 2022 at 5AM, "ROSAL" transitions into a Post-Tropical Low.

Hazards affecting Land Areas

• The post-tropical low is too far to directly affect the weather condition in the country.

Hazards affecting Coastal Waters

 Although no longer enhanced by the post-tropical low, under the influence of the surge of the Northeast Monsoon, a marine gale warning is in effect over the seaboards of Northern Luzon and



the eastern seaboard of Central Luzon. For more information, refer to Gale Warning #29 issued at 5:00 AM today. Furthermore, moderate to rough seas over the eastern seaboards of Southern Luzon (1.2 to 4.0 m) and Visayas (1.2 to 3.0 m). These conditions may be risky for those using small seacrafts. Mariners are advised to take precautionary measures when venturing out to sea and, if possible, avoid navigating in these conditions.

Track and Intensity Outlook

• This post-tropical low is forecast to dissipate within 24 hours due to the unfavorable conditions brought about by the surge of the Northeast Monsoon.

The center of Low Pressure Area (formerly ROSAL) was estimated based on all available data 1,020 km East of Extreme Northern Luzon (19.5 °N, 131.2 °E) moving Southeastward at 10 km/h with maximum sustained winds of km/h near the center and gustiness of up to km/h.



1. Standby Funds
