1. Standby Funds

- ₱23.75 million Quick Response Fund (QRF) at the DSWD Central Office.
- ₱5 million available at DSWD FO NCR.

2. Prepositioned FFPs and Other Relief Items

- 87,371 FFPs available in Disaster Response Centers; of which, 57,165 FFPs are at the National Resource Operations Center (NROC), Pasay City and 30,206 FFPs are at the Visayas Disaster Resource Center (VDRC), Mandaue City.
- 12,597 FFPs available at DSWD FO NCR.
- ₱331.51 million worth of other FNIs at NROC, VDRC, and DSWD FO NCR warehouses.

b. Food and Non-food Items (FNIs)
