



DSWD DROMIC Report #1 on the Fire Incident in Molo, Iloilo City

as of 29 January 2023, 6PM

I. Situation Overview

On 28 January 2023 at around 4:37 AM, a fire incident occurred in Barangays West Habog-Habog and San Juan in Molo, Iloilo City. It was declared fire out at around 6:16 AM. The cause of fire is still under investigation.

1. Standby Funds

- ₱998.1 million Quick Response Fund (QRF) at the DSWD Central Office.
- ₱5 million available at DSWD FO VI.

2. Prepositioned FFPs and Other Relief Items

- 69,125 FFPs available in Disaster Response Centers; of which, 12,119 FFPs are at the National Resource Operations Center (NROC), Pasay City and 57,006 FFPs are at the Visayas Disaster Resource Center (VDRC), Mandaue City.
- 43,315 FFPs available at DSWD FO VI.
- ₱353.87 million worth of other FNIs at NROC, VDRC, and DSWD FO VI warehouses.





b. Food and Non-food Items (FNIs)

DATE	ACTIVITIES
28 January 2023	 DSWD FO VI in coordination with the LGU of Iloilo City facilitated the hauling and initial augmentation of 300 FFPs, 40 Hygiene Kits, 40 Sleeping Kits, 40 Family Kits, and 40 Kitchen Kits intended for the affected families. The LGU of Iloilo City provided Food and Non-food Items to the displaced families.

c. Camp Coordination and Camp Management (CCCM)

28 January 2023	DSWD FO-VI through the Disaster Response and Rehabilitation Section (DRRS) assisted the City Social Welfare and Development Office (CSWDO) in the management of Internally Displaced Persons (IDPs), distribution of FNIs and validation of the affected families.
