

DSWD DROMIC Report #2 on the Fire Incident in Brgy. Ibo, Lapu-Lapu City, Cebu as of 20 January 2023, 6PM

I. Situation Overview

On 16 January 2023 at around 10:51 AM, a fire incident occurred at Sitio Commonwealth, Brgy. Ibo, Lapu-Lapu City, Cebu. The fire was declared out at around 12:30 PM.

III. Status of Displaced Population

a. Inside Evacuation Center

There are **131 families** or **337 persons** currently taking temporary shelter at the **Barangay Ibo Gymnasium in Lapu-Lapu City, Cebu** (see Table 2).

V. Cost of Humanitarian Assistance Provided

A total of **₱2,411,213.70** worth of assistance was provided to the affected families; of which, **₱897,135.50** was provided by **DSWD**, **₱1,444,857.20** from the **Local Government Unit (LGU)**, **₱8,500.00** from the **Non-Government Organizations (NGOs)** and **₱60,721.00** from **other Partners** (see Table 4).
