

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Onse, San Juan City

06 May 2024, 6AM

I. Situation Overview

On 08 January 2023 at around 4:45 PM, a fire incident occurred at No. 3 Cypress St. Brgy. Onse, San Juan City. The fire was declared out at around 5:34 PM.

A total of **23 families** or **72 persons** were affected in **Brgy. Onse, San Juan City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **23 families** or **72 persons** sought temporary shelter at the **Multi-Purpose Hall** in **Brgy. Onse, San Juan City** (see Annex B).

IV. Damaged Houses

A total of **eight (8) houses** were **totally damaged** in **Brgy. Onse, San Juan City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱348,400.00** worth of assistance was provided to the affected families; of which, **₱118,400.00** from **DSWD** and **₱230,000.00** from the **Local Government Unit (LGU)** (see Annex D).
