I. Situation Overview

On 30 January 2023 at around 12:18 in the afternoon, a fire incident occurred in Brgy. 209, Manila City. The fire was declared out at around 1:48 PM.

1. Standby Funds

- ₱923.49 million Quick Response Fund (QRF) at the DSWD-Central Office.
- ₱5 million available at DSWD-FO NCR.

2. Prepositioned FFPs and Other Relief Items

- 91,977 FFPs available in Disaster Response Centers; of which, 26,671 FFPs are at the National Resource Operations Center (NROC), Pasay City and 65,306 FFPs are at the Visayas Disaster Response Center (VDRC), Cebu City.
- 12,145 FFPs available at DSWD-FO NCR.
- ₱115.84 million worth of other FNIs at NROC, VDRC and DSWD-FO warehouses countrywide.

b. Food and Non-food Items (FNIs)

30 January 2023	 The LGU of Manila City through its Manila Department of Social Welfare (MDSW) provided hot meals (breakfast, lunch, and dinner) and facilitated the provision of other relief goods and construction supplies to the affected families.

c. Camp Coordination and Camp Management (CCCM)

30 January 2023	 The LGU of Manila City through its MDSW activated CCCM and other response clusters. They maintain close coordination with other government agencies and, conduct assessment and validation of affected families.

30 January 2023	 DSWD FO NCR continuously coordinates with the LGU of Manila City through its MDSW for significant updates and any request of relief augmentation.
