I. Situation Overview

On 15 February 2023 at around 4:40 PM, a fire incident occurred in Brgy. Sta. Cruz, Manila City. The fire was declared out at around 7:41 PM.

- 162,909 FFPs available in Disaster Response Centers; of which, 82,141 FFPs are at the National Resource Operations Center (NROC), Pasay City and 80,768 FFPs are at the Visayas Disaster Resource Center (VDRC), Mandaue City.

- ₱338.88 million worth of other FNIs at NROC, VDRC, and DSWD FO NCR warehouses.
