On 18 February 2023 at around 9:05 PM, a fire incident occurred in Brgy. Tatalon, Quezon City. The fire was declared out at around 12:41 AM.

2. Prepositioned FFPs and Other Relief Items

- 102,977 FFPs available in Disaster Response Centers; of which, 85,530 FFPs are at the National Resource Operations Center (NROC), Pasay City and 17,447 FFPs are at the Visayas Disaster Resource Center (VDRC), Mandaue City.
- 9,443 FFPs available at DSWD FO NCR.
- ₱335.04 million worth of other FNIs at NROC, VDRC, and DSWD FO NCR warehouses.





b. Food and Non-food Items (FNIs)

20 February 2023	 DSWD FO NCR through its Disaster Response Management Division (DRMD) provided FFPs and sleeping kits to the affected families as requested by the LGU of Quezon City through its Social Services and Development Department (SSDD).
19 February 2023	 The LGU of Quezon City through its SSDD provided hot meals and other basic needs to the affected families. The LGU of Quezon City put up a community kitchen.

c. Camp Coordination and Camp Management (CCCM)

20 February 2023	 The LGU of Quezon City through its SSDD continuously conducted intake interviews, assessment, validation, and masterlisting of the affected families.

d. Other Activities

19 February 2023	 DSWD FO NCR coordinated with the LGU of Quezon City through its SSDD for significant updates and any request of relief augmentation. DSWD FO NCR ensured availability of FNIs for possible augmentation to Quezon City.
