

## DSWD DROMIC Report #3 on the Armed Conflict in Brgy. Oringao, Kabankalan City, Negros Occidental

as of 07 February 2023, 6PM

### I. Situation Overview

On 04 February 2023 at around 4:30 PM, an armed conflict transpired between the Armed Forces of the Philippines (AFP) and members of the New People's Army (NPA) in Brgy. Oringao, Kabankalan City, Negros Occidental.

A total of **285 families** or **829 persons** are affected in **Brgy. Oringao, Kabankalan City, Negros Occidental** (see Table 1).

### III. Status of Displaced Population

#### a. Inside Evacuation Center

A total **285 families** or **829 persons** sought temporary shelter at the **Covered Court** in **Brgy. Oringao, Kabankalan City, Negros Occidental** (see Table 2). These families have returned to their respective residences after the safety clearance from the Philippine Army was issued.
