

## DSWD DROMIC Report #3 on the Fire Incident in Brgy. Calumpang, General Santos City

as of 03 March 2023, 6PM

### I. Situation Overview

On 21 February 2023 at around 3:30 AM, a fire incident occurred at Purok Lower Acharon, Brgy. Calumpang, General Santos City.
