



# **DSWD DROMIC Report #4 on the Fire Incident in Molo, Iloilo City**

as of 05 February 2023, 6PM

#### I. Situation Overview

On 28 January 2023 at around 4:37 AM, a fire incident occurred in Barangays West Habog-Habog and San Juan in Molo, Iloilo City. It was declared fire out at around 6:16 AM.

# III. Status of Displaced Population

#### a. Inside Evacuation Center

There are **262 families** or **1,001 persons** currently taking temporary shelter in **two (2) evacuation centers** in **Molo, Iloilo City** (see Table 2).
