

## DSWD DROMIC Terminal Report on the Armed Conflict in Brgy. Laconon, T'boli, South Cotabato

04 April 2023, 6PM

### I. Situation Overview

On 19 February 2023 at around 5:39 AM, an armed conflict transpired at Purok Alaw, Sitio Lembed, Brgy. Laconon, T'boli, South Cotabato between the 5th Special Forces Battalion of the Philippine Army (PA) and alleged member of the New People's Army (NPA).

A total of **₱31,857.00** worth of assistance was provided by **DSWD** to the affected families (see Table 3).


