





# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Malawag, Nabua, Camarines Sur

06 April 2024, 6AM

#### I. Situation Overview

On 21 February 2023 at around 1AM, a fire incident occurred at Brgy. Malawag, Nabua, Camarines Sur. The cause of fire was due to electrical ignition that resulted in overloading of electricity.
