I. Situation Overview

On 21 March 2023 at around 6:29 AM, a fire incident occurred in Brgy. 317, Zone 32, Manila City. The fire was declared out at around 7:51 AM.

1. Standby Funds

- ₱671.31 million Quick Response Fund (QRF) at the DSWD Central Office.

2. Prepositioned FFPs and Other Relief Items

- 102,693 FFPs available in Disaster Response Centers; of which, 24,546 FFPs are at the National Resource Operations Center (NROC), Pasay City and 78,147 FFPs are at the Visayas Disaster Resource Center (VDRC), Mandaue City.
- 6,889 FFPs available at DSWD FO NCR.
- ₱328,90 million worth of other FNIs at NROC, VDRC, and DSWD FO NCR warehouses.
