I. Situation Overview

On 24 March 2023 at around 9:49 PM, a fire incident occurred at Airport Village, Brgy. Moonwalk, Parañaque City. The fire was declared out at around 11:54 PM.

1. Standby Funds

- ₱671.31 million Quick Response Fund (QRF) at the DSWD Central Office.
- ₱5 million available at DSWD FO NCR.

2. Prepositioned FFPs and Other Relief Items

- 88,575 FFPs available in Disaster Response Centers; of which, 39,728 FFPs are at the National Resource Operations Center (NROC), Pasay City and 48,847 FFPs are at the Visayas Disaster Resource Center (VDRC), Mandaue City.
- 6,889 FFPs available at DSWD FO NCR.
- ₱314.59 million worth of other FNIs at NROC, VDRC, and DSWD FO NCR warehouses.
