



DSWD DROMIC Report #2 on the Armed Conflict in Brgy. Carabalan, Himamaylan City, Negros Occidental

as of 02 March 2023, 6PM

I. Situation Overview

On 01 March 2023 at around 6:20 AM, an armed conflict transpired between the Armed Forces of the Philippines (AFP) and members of the New People's Army (NPA) in Brgy. Carabalan, Himamaylan City, Negros Occidental.

A total of **181 families** or **905 persons** are affected in **Brgy. Carabalan**, **Himamaylan City** (see Table 1).

1. Standby Funds

- ₱748.73 million Quick Response Fund (QRF) at the DSWD Central Office.
- ₱2.5 million available at DSWD FO VI.

2. Prepositioned FFPs and Other Relief Items

- 120,075 FFPs available in Disaster Response Centers; of which, 70,728 FFPs are at the National Resource Operations Center (NROC), Pasay City and 49,347 FFPs are at the Visayas Disaster Resource Center (VDRC), Mandaue City.
- 62,262 FFPs available at DSWD FO VI.
- ₱365.14 million worth of other FNIs at NROC, VDRC, and DSWD FO VI warehouses.

b. Food and Non-food Items (FNIs)

01 March 2023	 The LGU of Himamaylan City, in coordination with the Armed Forces of the Philippines (AFP), City Social Welfare and Development Office (CSWDO) and the BLGU of Carabalan, immediately provided hot meals and FNIs to the affected families. DSWD FO VI through its City Action Team (CAT) coordinated with the CSWDO of the LGU of Himamaylan City for the distribution of FNIS such as FFPs and hygiene kits to the affected families.





c. Other Activities

01 March 2023	 DSWD FO VI continuously coordinated with the CSWDO of the LGU of Himamaylan City for significant updates and any request of relief augmentation. The LGU of Himamaylan City, through its CSWDO, City Disaster Risk Reduction and Management Office (CDRRMO), and BLGU of Carabalan, continuously monitored the situation and assists the internally displaced population (IDP).
