## I. Situation Overview

On 01 March 2023 at around 6:20 AM, an armed conflict transpired between the Armed Forces of the Philippines (AFP) and members of the New People's Army (NPA) in Brgy. Carabalan, Himamaylan City, Negros Occidental.

### 1. Standby Funds

- ₱748.73 million Quick Response Fund (QRF) at the DSWD Central Office.
- ₱2.5 million available at DSWD FO VI.

### 2. Prepositioned FFPs and Other Relief Items

- 126,871 FFPs available in Disaster Response Centers; of which, 72,724 FFPs are at the National Resource Operations Center (NROC), Pasay City and 54,147 FFPs are at the Visayas Disaster Resource Center (VDRC), Mandaue City.
- 62,262 FFPs available at DSWD FO VI.
- ₱364.46 million worth of other FNIs at NROC, VDRC, and DSWD FO VI warehouses.
