

## DSWD DROMIC Terminal Report on the Armed Conflict in Brgy. Carabalan, Himamaylan City, Negros Occidental

17 May 2023, 6PM

### I. Situation Overview

On 01 March 2023 at around 6:20 AM, an armed conflict transpired between the Armed Forces of the Philippines (AFP) and members of the New People's Army (NPA) in Brgy. Carabalan, Himamaylan City, Negros Occidental.
