

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Basak San Nicolas, Cebu City, Cebu

11 February 2024, 6PM

I. Situation Overview

On 07 March 2023 at around 3:49 PM, a fire incident occurred at Sitio Upper Tabucanal, Brgy. Basak San Nicolas, Cebu City. The fire was declared out at around 4:34 PM.

Relative to the incident, the DSWD through its Field Office in Region VII together with the LGU of Cebu City, provided relief and financial assistance to support the immediate needs of the affected families and individuals.

II. Status of Affected Areas and Population

A total of **19 families** or **80 persons** were affected in **Brgy. Basak San Nicolas, Cebu City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **19 families** or **80 persons** sought temporary shelter at the **Looc Covered Court** in **Brgy. Basak San Nicolas, Cebu City** (see Annex B).

IV. Damaged Houses

A total of **11 houses** were **totally damaged** in **Brgy. Basak San Nicolas, Cebu City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱598,936.50** worth of assistance was provided to the affected families; composed of **₱298,936.50** from **DSWD** and **₱300,000.00** from the **Local Government Unit (LGU)** (see Annex D).
