07 April 2024, 6AM

I. Situation Overview

On 13 March 2023 at around 5:30 PM, a fire incident occurred at Brgy. Cullat, Daraga, Albay.

Relative to the incident, the DSWD through its Field Office in Region V, provided relief augmentation to support the immediate needs of the affected family.
