





DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Maulawin, Santa Elena, Camarines Norte

I. Situation Overview

On 13 March 2023 a fire incident occurred at Brgy. Maulawin, Santa Elena, Camarines Norte.

Relative to the incident, the DSWD through its Field Office in Region V, provided relief augmentation to support the immediate needs of the affected family.

Outside Evacuation Center

One (1) family or four (4) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy Maulawain, Santa Elena, Camarines Norte (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P9,932.05** worth of assistance was provided by the **DSWD** to the affected family (see Annex D).
