## DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Maulawin, Santa Elena, Camarines Norte 07 April 2024, 6AM

### I. Situation Overview

On 13 March 2023 a fire incident occurred at Brgy. Maulawin, Santa Elena, Camarines Norte.

Relative to the incident, the DSWD through its Field Office in Region V, provided relief augmentation to support the immediate needs of the affected family.

**One (1) family or four (4) persons** temporarily stayed with their relatives (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy Maulawain, Santa Elena, Camarines Norte** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱9,932.05** worth of assistance was provided by the **DSWD** to the affected family (see Annex D).
