

## DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Sto. Niño, Parañaque City

21 October 2023, 6PM

### I. Situation Overview

On 27 March 2023 at around 11:44 AM, a fire incident occurred at Golden Shine Ville and South Ville Area 1, Sitio Libjo, Brgy. Sto. Niño, Parañaque City. The fire was declared out at around 1:04 PM.
