



DSWD DROMIC Report #1 on the Armed Conflict in La Paz, Agusan del Sur

as of 18 April 2023, 6PM

I. Situation Overview

On 17 March 2023, an armed conflict transpired at Sitio Liwangwangan, Brgy. Lydia, La Paz, Agusan del Sur between the Philippine Army and alleged members of the Sub-Regional Sentro De Gravidad (SRSDG) Sagay. The residents in the area have evacuated on 10 April 2023 due to fear that another encounter may happen.

A total of **81 families** or **404 persons** are affected in **Brgy. Lydia**, **La Paz**, **Agusan del Sur** (see Table 1).

- 54,705 FFPs available in Disaster Response Centers; of which, 23,177 FFPs are at the National Resource Operations Center (NROC), Pasay City and 31,528 FFPs are at the Visayas Disaster Resource Center (VDRC), Mandaue City.
- 41,002 FFPs available at DSWD FO Caraga.
