I. Situation Overview

On 02 April 2023 at around 9:55 AM, a fire incident occurred in Brgy. Pal-agon, Pavia, Iloilo. The Bureau of Fire Protection (BFP) responded immediately to put off the fire, which allegedly caused by an uncontrolled fire while cooking. The fire was declared out at around 11:45 AM.
