I. Situation Overview

On 24 April 2023 at around 6AM, a fire incident occurred at Purok 7, PNR Site, Brgy. Western Bicutan, Taguig City. The fire was declared out

1. Standby Funds

- ₱28.48 million Quick Response Fund (QRF) at the DSWD Central Office.
- ₱4.90 million available at DSWD FO NCR.

2. Prepositioned FFPs and Other Relief Items

- 27,854 FFPs available in Disaster Response Centers; of which, 1,226 FFPs are at the National Resource Operations Center (NROC), Pasay City and 26,628 FFPs are at the Visayas Disaster Resource Center (VDRC), Mandaue City.
- 6,342 FFPs available at DSWD FO NCR.


d. Other Activities
