I. Situation Overview

On 05 April 2023 at around 5:42 PM, a fire incident occurred at Sitio Bato, Brgy. Ermita, Cebu City. The fire was declared out around 6:38 PM.

A total of **233 families** or **887 persons** are affected in **Brgy. Ermita, Cebu City** (see Table 1).

a. Inside Evacuation Center

A total of 233 families or 887 persons sought temporary shelter in two (2) evacuation centers in Brgy. Ermita, Cebu City (see Table 2).

12 April 2023	• DSWD FO VII facilitated the provision of financial assistance for food to the affected families through the Assistance to Individuals in Crisis Situation (AICS) amounting to a total of ₱1,110,000.00.
06 April 2023	• DSWD FO VII through its Disaster Response Management Division (DRMD) coordinated with the LGU of Cebu City for significant updates and any request of relief augmentation.
