## I. Situation Overview

On 16 April 2023 at around 12PM, a fire incident occurred at Sitio Nabuloan, Brgy. Bucalan, Canlaon City. The fire incident was declared out at around 1:20PM.

A total of **₱8,906.00** worth of assistance was provided to the affected family composed of **₱6,906.00** from **DSWD** and **₱2,000.00** from the **Local Government Unit (LGU)** (see Annex D).
