I. Situation Overview

On 09 April 2023 at around 12:30 AM, a fire incident occurred at Sitio Batobato, Brgy. Dolores, Taytay, Rizal. The fire was declared out at around 3:20 AM.

A total of **113 families** or **469 persons** sought temporary shelter at the **Golden City Covered Court** in **Brgy. Dolores, Taytay, Rizal** (see Table 2).
