

DSWD DROMIC Preparedness for Response Report #2 on the Super Typhoon (STY) “Mawar” as of 26 May 2023, 6PM

Situation Overview

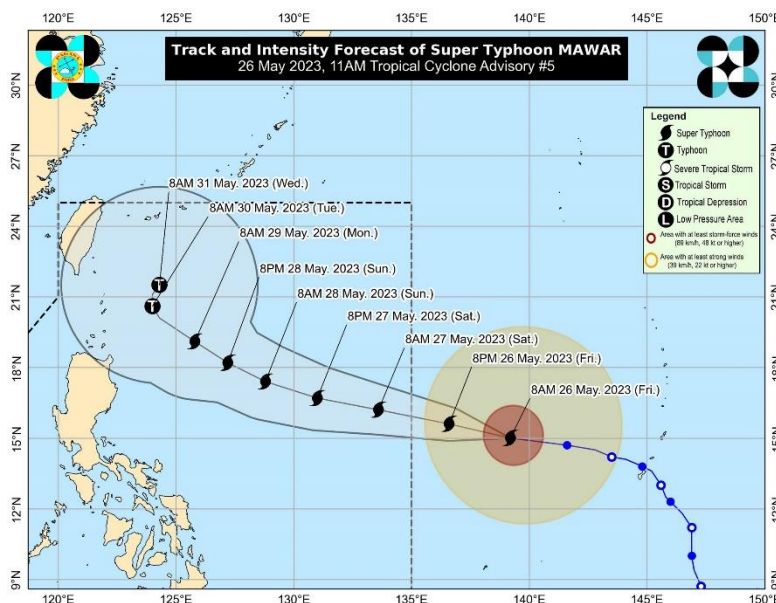
Issued on 26 May 2023 at 11 AM, “Mawar” slightly intensifies while moving westward over the Philippine Sea at 20km/h.

Location of Center (10 AM):

The center of the eye of Super Typhoon “MAWAR” was estimated based on all available data at 1,705 km East of Southeastern Luzon (15.1°N, 138.8°E).

Intensity:

Maximum sustained winds of 215 km/h near the center, gustiness of up to 260 km/h, and central pressure of 905 hPa.



Extent of Tropical Cyclone Winds:

Strong to typhoon-force winds extend outwards up to 550 km from the center.

General Outlook for the Forecast Period

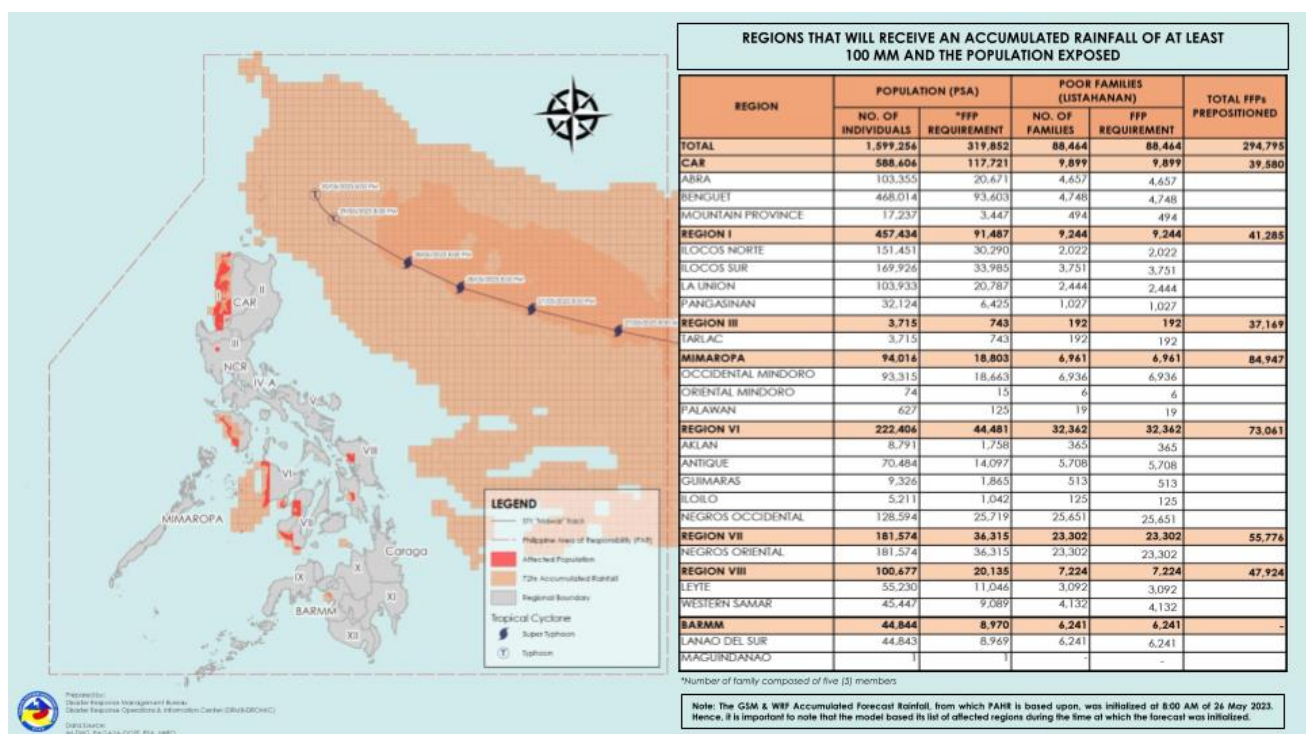
- Super Typhoon MAWAR is forecast to track generally west northwestward until Sunday while accelerating before turning northwestward on Sunday. On the track forecast, the super typhoon will enter the Philippine Area of Responsibility (PAR) tonight or tomorrow early morning. MAWAR will begin to decelerate on Sunday as it begins to move closer towards the waters east of Extreme Northern Luzon. The center of MAWAR’s eye is forecast to be within 250 km of the Batanes-Babuyan archipelago by next week during the slowdown period.
- “Mawar” is forecast to reach its peak intensity within 24 hours. The super typhoon may slightly weaken by tomorrow evening but is expected to remain as a super typhoon until Monday morning due to highly favorable environment. “Mawar” will then weaken at a slightly faster rate by late Monday or Tuesday as unfavorable conditions (e.g., increasing wind shear, cooler sea surface temperature resulting from its slowdown by that time, dry air intrusion) take place.
- Current forecast scenario shows that the typhoon may bring heavy rains (which may trigger flooding or rain-induced landslides) over Northern Luzon beginning late Sunday or on Monday next week. In addition, strong to storm-force conditions may be experienced over Extreme Northern Luzon, while strong to gale-force conditions are possible over the northern and eastern portions of Northern Luzon mainland. As a

result, wind signals will be raised by tomorrow evening in preparation for these severe winds.

- “Mawar” is also forecast to enhance the Southwest Monsoon which may bring monsoon rains over the western portions of Central Luzon, Southern Luzon, and Visayas beginning on Sunday or Monday.

Status of Prepositioned Resources: Stockpile and Standby Funds

The DSWD Central Office (CO), Field Offices (FOs), and National Resource Operations Center (NROC) have stockpiles and standby funds amounting to **₱2,166,313,565.88** with breakdown as follows (see Table 1):

a. Standby Funds

A total of **₱598,542,046.87** standby funds in the CO and FOs. Of the said amount, **₱525,218,364.15** is the available **Quick Response Fund (QRF)** in the CO.

b. Stockpiles

A total of **800,079 family food packs (FFPs)** amounting to **₱528,535,682.94**, **other food items** amounting to **₱220,192,174.87**, and **non-food items (NFIs)** amounting to **₱819,043,661.20** are available

25 May 2023	<ul style="list-style-type: none"> The Local Government Unit (LGU) of Roxas, Palawan provided hot meals/food assistance to the families and individuals who were pre-emptively evacuated. 10,500 FFPs were in transit from NRLMB to Puerto Princesa City warehouse as prepositioned relief goods. FFPs were hauled and delivered to the Municipalities of Dumarán, Quezon, Brooke's Point, Sofronio Española, Bataraza, Balabac, and Taytay in Palawan.

DRMB closely coordinates with the DSWD FOs for disaster preparedness measures and activities. DRMB closely coordinates with DOST-PAGASA for significant weather updates and other related information relative to STY "Mawar". All DRMB Quick Response Team (QRT) members and emergency equipment are on standby and ready for deployment. The National Resource and Logistics Management Bureau (NRLMB) ensures the replenishment and availability of Food and Non-Food Items (FNIs) for resource augmentation to DSWD FOs as need arises. DSWD-NRLMB continuously repacks goods for possible augmentation.
25 May 2023	<ul style="list-style-type: none"> Undersecretary for Disaster Response Management Group (DRMG) Dr. Diana Rose Cajipe, together with Special Assistant to the Secretary (SAS) for Disaster Response Management Ma. Isabel Lanada, SAS for Supply Chain Management and Logistics Marlon A. Alagao, and DSWD FOs, led and convened the meeting on DSWD Disaster Preparedness for Response on the Possible Effects of STY "Mawar".

DSWD FO NCR closely coordinates with the LGUs through their respective Local Social Welfare and Development Offices (LSWDOs) and with Metro Manila Disaster Risk Reduction and Management Council (MMDRRMC) for reports on incidents requiring augmentation assistance. Some members of the DSWD FO NCR QRT and the Motorcycle Riders Group are activated and on standby to respond to any eventualities. Volunteers who are assigned at DSWD FO NCR warehouse in Pasay City have been notified for duty to augment in the repacking of relief goods.

DSWD FO CAR is in close coordination with the LGUs for additional prepositioning of FNIs to their designated hubs. DSWD FO CAR ensures availability of transportation and communication services ready for possible deployment if needed. DSWD FO CAR closely coordinates with the Emergency Telecommunications Team for the testing of communication equipment. DSWD FO CAR coordinates with volunteers and service providers for the hauling of scheduled deliveries of FNIs. DSWD FO CAR QRTs are on standby and ready for deployment.

DSWD FO I closely coordinates with the Provincial Disaster Risk Reduction and Management Councils (PDRRMCs) and the Provincial Social Welfare and Development Offices (PSWDOs) to monitor the possible effects of the current weather condition and to ensure submission of reports when needed. DSWD FO I staff in different Provincial Operations Offices (POOs) are closely monitoring their respective (AORs) for any eventualities. Members of the Incident Management Team (IMT) are on standby for possible activation of the DSWD FO I IMT while other DSWD staff are on stand by for possible conduct of disaster response operations. DSWD FO I ensures the availability of all resources for possible augmentation to affected LGUs.

DSWD FO III

All SWAD Offices of DSWD FO III are enjoined to observe precautionary measures and monitor the possible effects of the weather system in their respective AORs.
25 May 2023	<ul style="list-style-type: none"> DSWD FO III QRTs are ready for deployment once alert level status of the RDRRMC 3 is raised to Blue/Red. The QRT members were provided with refresher course on their roles and responsibilities during disaster response operations. Most of the team leaders were trained on Camp Coordination and Camp Management (CCCM). Other members were trained on Mental Health and Psychosocial Support, and Basic First Aid. The Active Rapid Deployment Team is on standby for continuous monitoring of STY “Mawar”.

DSWD FO CALABARZON EOC continuously conducts weather monitoring through DOST-PAGASA. DSWD FO CALABARZON closely coordinates with the RDRRMC IV-A Operations Center and PSWDOs for any significant updates relative to STY “Mawar”. DSWD FO CALABARZON attended the virtual meeting with the DSWD Central Office and all DSWD FOs relative to the Department’s preparedness measures.
