I. Situation Overview

On 21 May 2023 at around 3:16 PM, a maritime collision incident between a fast craft and cargo vessel occurred along Mactan Channel near the Marcelo Fernan Bridge.

The Disaster Response Operations Monitoring and Information Center (DROMIC) of DSWD-DRMB is closely coordinating with DSWD FO VII for significant disaster response updates and assistance provided.
