I. Situation Overview

On 18 May 2023 at around 2:30 PM, a tornado was experienced in Brgy. Bantayan, Kabankalan City, Negros Occidental.

• ₱878.99 million Quick Response Fund (QRF) at the DSWD Central Office.

2. Prepositioned FFPs and Other Relief Items

- 89,229 FFPs available in Disaster Response Centers; of which, 80,087 FFPs are at the National Resource Operations Center (NROC), Pasay City and 9,142 FFPs are at the Visayas Disaster Resource Center (VDRC), Mandaue City.
- 73,209 FFPs available at DSWD FO VI.
- ₱236 million worth of other FNIs at NROC, VDRC, and DSWD FO VI warehouses.
