

## DSWD DROMIC Report #5 on the Flashflood Incidents in Region XII

as of 01 June 2023, 6PM

### I. Situation Overview

On 15 May 2023, partly cloudy to cloudy skies with isolated rainshowers or thunderstorms caused by the Southwesterly Surface Windflow / Localized may have brought possible flashfloods or landslides during severe thunderstorms to Metro Manila and the rest of the country.

On the same day, several municipalities in the provinces of Sultan Kudarat, South Cotabato, and Cotabato Province experienced flashfloods.

A total of **1,667 families** or **5,850 persons** are affected in **15 barangays** in **Region XII** (see Table 1).
