



DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Poblacion, Trinidad, Bohol

19 February 2024, 6AM

I. Situation Overview

A fire broke out in the residential and commercial area of Brgy. Poblacion in Trinidad, Bohol, on May 15, 2023, around 7:00 am, and was successfully extinguished by 8:00 am.

Following validation, the LGU reported that 2 boarding houses, accommodating 58 residents, primarily students from Trinidad Municipal College, and 2 commercial establishments were reported affected.

In response to the incident, the DSWD through its Field Office in Region VII, together with the Local Government unit (LGU) of Trinidad, Bohol, extended relief augmentation composed of Food and Non-Food Items (NFIs), to support the immediate needs of the affected populace.

II. Status of Affected Areas and Population

A total of **41 families** or **58 persons** were affected in **Brgy. Poblacion, Trinidad, Bohol** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **41 families** or **58 persons** sought temporary shelter in **Trinidad Evacuation Center** in **Trinidad**, **Bohol** (see Annex B).

IV. Damaged Houses

A total of **nine (9) houses** were damaged; of which, **seven (7)** are **totally damaged** and **two (2)** are **partially damaged** in **Brgy. Poblacion, Trinidad, Bohol** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱218,617.50** worth of assistance was provided to the affected families; composed of **₱83,617.50** from **DSWD** and **₱135,000.00** from the **Local Government Unit (LGU)** (see Annex D).
