

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Rizal Pala Pala II, Iloilo City

22 November 2023, 6PM

I. Situation Overview

On 29 April 2023 at around 8:50 AM, a fire transpired in Barangay Rizal Pala-Pala II, Iloilo City Proper. As per report submitted by the City Social Welfare and Development Office (CSWDO), the incident resulted in the displacement of 162 families, equivalent to 379 individuals. The incident led to the destruction of 78 residential houses, with 52 being completely damaged and 26 partially damaged.

The Bureau of Fire Protection (BFP) promptly intervened, and the fire was declared extinguished at approximately 10:36 AM. Likewise, there are no reported casualties.

A total of **162 families** or **379 persons** sought temporary shelter in **Brgy. Rizal Pala Pala II, Iloilo City** (see Table 2).
