

DSWD DROMIC Report on the Fire Incident in Brgy. Santa Rosa-Laguna, Guimbal, Iloilo

29 June 2023, 6PM

I. Situation Overview

On 26 April 2023 at around 7:41 PM, a fire incident occurred in Brgy. Santa Rosa-Laguna, Guimbal, Iloilo. According to the Bureau of Fire Protection (BFP), the fire was caused by faulty electrical wiring and was declared out at around 8:00 PM.
