I. Situation Overview

On 05 June 2023, a fire incident occurred in Brgy. Barucboc, Quezon, Isabela.

A total of **two (2) families** or **eight (8) persons** were affected in **Brgy. Barucboc, Quezon, Isabela** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **eight (8) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were **totally damaged** in **Brgy. Barucboc, Quezon, Isabela** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱42,202.50** worth of assistance was provided to the affected families; of which, **₱32,202.50** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
