16 March 2024, 6AM

I. Situation Overview

On 14 June 2023 at around 3:19 PM, a fire incident occurred in Brgy. Canmogsay, Tolosa, Leyte.

A total of **three (3) families** or **nine (9) persons** were affected in **Brgy. Canmogsay, Tolosa, Leyte** (see Annex A).

III. Status of Displaced Population

- a. Inside Evacuation Center
 There are two (2) families or eight (8) persons displaced in Brgy. Canmogsay,
 Tolosa, Leyte (see Annex B).
- b. Outside Evacuation Center
 One (1) person stayed with their relatives or friends (see Annex C).
- c. Total Displaced Population
 There are three (3) families or nine (9) persons displaced in Brgy.
 Canmogsay, Tolosa, Leyte (see Annex D).

IV. Damaged Houses

A total of **two (2) houses** were damaged in **Brgy. Canmogsay, Tolosa, Leyte** (see Annex E).

V. Cost of Humanitarian Assistance Provided

A total of **₱38,984.08** worth of assistance from **DSWD** was provided to the affected families. (see Annex F).
