Situation Overview


Issued on 21 July 2023 at 5PM, "Egay" maintains its strength as it accelerates West Northwestward over the Philippine Sea.

HAZARDS AFFECTING LAND AREAS

Heavy Rainfall Outlook

- Forecast accumulated rainfall from Sunday afternoon to Monday afternoon
 - 50-100 mm: Catanduanes and Northern Samar

In areas that will not be directly



affected by "Egay", monsoon rains from the enhanced Southwest Monsoon are possible over the western section of MIMAROPA and Visayas on Sunday. On Monday and Tuesday, monsoon rains are likely over the western section of Southern Luzon and Western Visayas.

Under these conditions, flooding and rain-induced landslides are possible, especially in areas that are highly or very highly susceptible to these hazard as identified in hazard maps and in localities that experienced considerable amounts of rainfall for the past several days.

Severe Winds

- In anticipation of possible strong breeze to gale-force conditions (up to 65 km/h) caused by "Egay", Wind Signals may be hoisted in some areas of Bicol Region and Eastern Visayas (especially in the eastern portion) tonight or tomorrow morning.
- The enhanced Southwest Monsoon may bring strong breeze to near gale conditions with intermittent gusts beginning tomorrow afternoon over MIMAROPA, Western Visayas, and western portions of Mindanao

HAZARDS AFFECTING COASTAL WATERS

On Sunday, "Egay" may bring moderate to rough seas (2.0 to 3.5 m) over the eastern seaboard of Southern Luzon and Eastern Visayas. Mariners of small seacrafts are advised to take precautionary measures when venturing out to sea. If inexperienced or operating ill-equipped vessels, avoid navigating in these conditions.





TRACK AND INTENSITY OUTLOOK

- "Egay" is forecast to track generally west northwestward until late Sunday before turning northwestward over the Philippine Sea east of Luzon for the remainder of forecast period. While the current track forecast shows that "Egay" will remain offshore over the waters east of Luzon, the forecast confidence cone shows that a landfall cenario over the eastern portion of mainland Cagayan and Batanes is not ruled out.
- "Egay" is forecast to intensify in the next 12 hours into a Tropical Storm. Throughout its duration in the PAR region, it may continue to steadily intensify and reach Super Typhoon category by late Monday or early Tuesday as it moves over the Philippine Sea east of Luzon.

The center of Tropical Depression "Egay" was estimated based on all available data at 835 km East of Southeastern Luzon (14.4°N, 131.9°E) moving West Northwestward at 20 km/h with maximum sustained winds of 55 km/h near the center and gustiness of up to 70 km/h. *Source: DOST-PAGASA Tropical Cyclone Bulletin* #2

Predictive Analytics for Humanitarian Response (PAHR)

Based on the Global Spectral Model (GSM) & Weather Research and Forecasting (WRF) Accumulated Forecast Rainfall initialized on **21 July 2023 at 8AM**, the PAHR results show that **36,977 families (PSA) or 3,568 poor families (Listahanan)** in **Regions CALABARZON**, **MIMAROPA**, V, IX, X, Caraga, and CAR may be affected by Tropical Depression "Egay".




Figure 1. Areas exposed to Accumulated Forecast Rainfall based on the GSM and WRF model.

Status of Prepositioned Resources: Stockpile and Standby Funds

The DSWD Central Office (CO), Field Offices (FOs), and National Resource Operations Center (NROC) have stockpiles and standby funds amounting to ₱2,052,652,436.59 with breakdown as follows (see Table 2):

a. Standby Funds

A total of ₱173,986,968.06 standby funds in the CO and FOs. Of the said amount, ₱98,861,092.41 is the available Quick Response Fund (QRF) in the CO.

b. Stockpiles

A total of 1,149,854 family food packs (FFPs) amounting to ₱756,192,637.70, other food items amounting to ₱264,558,342.23, and non-food items (NFIs) amounting to ₱857,914,488.60 are available

DSWD FO I continuously repacked FFPs at the Regional Warehouse with the help of community volunteers from San Juan, La Union. DSWD FO I staff in different Provincial Operations Offices (POOs) closely monitored their respective (AORs) for any eventualities. DSWD FO I ensured the availability of all resources for possible augmentation to affected LGUs. Members of the Incident Management Team (IMT) were on standby for possible activation of the DSWD FO I IMT while other DSWD staff were on standby for possible conduct of disaster response operations.
