I. Situation Overview

On 06 July 2023 at around 5:30 PM, a fire incident occurred at Loreto St., Brgy. 418, Sampaloc, Manila City. The fire was declared out at around 7PM.

1. Standby Funds

- ₱247.56 million Quick Response Fund (QRF) at the DSWD Central Office.
- ₱4.9 million available at DSWD FO NCR.

2. Prepositioned FFPs and Other Relief Items

- 168,407 FFPs available in Disaster Response Centers; of which, 108,965 FFPs are at the National Resource Operations Center (NROC), Pasay City and 59,442 FFPs are at the Visayas Disaster Resource Center (VDRC), Mandaue City.
- 6,938 FFPs available at DSWD FO NCR.
- ₱235.96 million worth of other FNIs at NROC, VDRC, and DSWD FO NCR warehouses.
