## I. Situation Overview

On 01 July 2023 at around 5:15 PM, a fire incident occurred at Jaguar St., Brgy. Fairview, Quezon City. The fire was declared out at around 7:45 PM.

## 1. Standby Funds

- ₱247.56 million Quick Response Fund (QRF) at the DSWD Central Office.
- ₱4.90 million available at DSWD FO NCR.

#### 2. Prepositioned FFPs and Other Relief Items

- 168,407 FFPs available in Disaster Response Centers; of which, 108,965 FFPs are at the National Resource Operations Center (NROC), Pasay City and 59,442 FFPs are at the Visayas Disaster Resource Center (VDRC), Mandaue City.
- 6,938 FFPs available at DSWD FO NCR.
- ₱235.96 million worth of other FNIs at NROC, VDRC, and DSWD FO NCR warehouses.





## b. Food and Non-food Items (FNIs)

06 July 2023	DSWD FO NCR through its Disaster Response Management Division (DRMD) provided FFPs, small hygiene kits, and family kits to the families affected by the fire incident.
03 July 2023	The Local Government Unit (LGU) of Quezon City through its Social Services Development Department (SSDD) provided hot meals and other basic needs to the affected families. Also, the same office facilitated the distribution of various donations to the affected families.
