





DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Calumpang, General Santos City

05 February 2024, 6AM

I. Situation Overview

On 11 July 2023 at around 8:00 PM, a fire incident occurred at Purok Lower Puting Bato in Brgy. Calumpang, General Santos City. The fire was declared out at around 11PM.

II. Status of Affected Areas and Population

A total of **34 families** or **170 persons** were affected in **Brgy. Calumpang, General Santos City** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **34 families** or **170 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **34 houses** were damaged; of which, **32** are **totally damaged** and **two (2)** are **partially damaged** in **Brgy. Calumpang, General Santos City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱305,932.00** worth of assistance was provided to the affected families; of which, **₱203,932.00** from **DSWD** and **₱102,000.00** from the **Local Government Unit (LGU)** (see Annex D).
